## Other Fees and Charges

**Enrolment Application Fee** (non-refundable) \$110 on application for admission. This fee does not guarantee a place in the School.

**Enrolment Confirmation Fee** (non-refundable) \$500 payable within 14 days of receiving notification of placement offer.

Some **additional student expenses** may need to be charged if incurred. These include non-curriculum related expenses and boarders' medical expenses.

**Chartered Bus Fares** are charged on fee accounts each Term. The cost of these buses varies depending which bus the student catches. Costs may be charged on a pro-rata basis (ie: change of address).

## Discounts

**Sibling Discount** – The Board of Trustees has approved the following discounts on tuition fees:

- For the second student from one family attending the School concurrently, 5%
- For third and subsequent students from one family attending the School concurrently, 10%
- Where a family has boys at IGS and girls at IGGS concurrently, 3.5%

**Early Payment Discount** – A discount of \$120 per semester on both tuition and boarding fees will apply if payment is received by 3.30pm one week prior to the due date and a 5% discount per year will apply if the years fees are paid by the Term 1 due date.

## Fee Payment Dates

**Tuition and boarding fees are charged by the semester. There are two (2) semesters per year. The payment of all school fees is required by the due date (first day of each semester).**

- Semester 1 fees payable by 22 January 2024 (early payment discount date is 15 January)
- Semester 2 fees payable by 9 July 2024 (early payment discount date is 2 July)

**Payment can be made by cash, EFTPOS, Direct Deposit or via Parent Lounge. Credit card payments made via Parent Lounge are free of surcharge. Credit card surcharge applies for all other credit card payments.**

## Voluntary Building Fund (tax deductible)

A building fund donation of \$50 or more can be made to the School. This contribution to the building fund enables voting rights in a single cycle of the Board of Trustees reconstitution. Current cycle April 2021 – April 2025.

## Withdrawal

The School commits resources based on confirmed enrolments. Once a student has been enrolled in the School, it is essential that parents/carers provide one full term's notice if they are intending to withdraw a student from the school. This should be done using our online withdrawal application form – [iggs.qld.edu.au/enrol/withdrawal-of-enrolment](https://iggs.qld.edu.au/enrol/withdrawal-of-enrolment). Failure to do so will result in one full term's tuition fees being charged in lieu of this notice.

## Board of Trustees – Fee Payment Policy

Payment of all fees by the due date is a condition of continued attendance at the School and the provision of education services. Failure to pay fees as and when due, may lead to the withdrawal of education services and the removal of the student from the School. The School also reserves the right to withhold student report cards and/or statements of reference if accounts remain overdue at the end of the term/semester.

Where fees are not paid by the due date, payment arrangements are available, however, such payments can only be made by direct bank debit authority. No other payment arrangements are acceptable.
